The above rates represent the current annual fees assessed by the Community. All assessments are due yearly and/or monthly.

## Annual Assessments are due on January 1<sup>st</sup>.

Payments not received by the **close of business on January 31**<sup>st</sup> are considered late and will be assessed applicable penalties. Any payments received on or after February 1<sup>st</sup> are late. Mailing/Postmark, E-Check, and Credit Card processing dates will not be accepted. Penalties are assessed based on the <u>received</u> date. It is recommended that a minimum of 7 days be allowed for mail and 3 days be allowed for credit card/online payments.

Note that a **separate payment** is required for each assessment owed; one combined payment will not be accepted. You will receive individual invoices for each Association (Bridgeland Council, Lakeland Village, Parkland Village, Prairieland Village, Townhome Association).

<u>Online Payments</u>: As a reminder, you may be charged a merchant fee for credit/debit payments. E-Check payments are free. The online payment portal link and approved 2021 Annual Budget will be posted on our website. Note that a **separate payment** is required for each assessment owed when using the online payment portal. Your account numbers and Association ID's can be found on their respective invoices. *For your reference, the Association ID's are as follows:* Bridgeland Council – 121, Lakeland Village – 122, Parkland Village – 124, Prairieland Village – 126, Lockhart Townhomes – 118, The Townhomes at Lakeland Heights – 119, Harmony Grove – 120.

**Payment Plans:** Residents may request an automatic 3-month payment plan by submitting a <u>written request</u> to the Association <u>before the January 1<sup>st</sup> due date</u>. The plan will divide your current year's assessments into 3 equal monthly payments, which will be due no later than January 31<sup>st</sup>, February 28<sup>th</sup>, and March 31<sup>st</sup>. Extended payment plans will be considered on a case-by-case basis based on circumstance. Accounts that have defaulted on a payment plan within the previous 2 years *may* not be eligible for a current payment plan.
